Dr. Helen Cuddihy is an experienced, innovative and authentic leader in her 25th year of frontline and senior administrative practice. She has centred her clinical work on child, adolescent, and women's health, with a special interest in mental, reproductive, and physician health. In contrast, she has focused her administrative work on organizational and staff development, innovative service delivery models, and sound fiscal and clinical management.
