Over the past year Rick Glazier, Lisa Dolovich and Peter Norton have served on a working group set up by the Institute for Health Services and Policy Research (IHSPR) to see how primary care researchers might better succeed in getting funding from the Canadian Institutes of Health Research (CIHR). As a result of their work, the IHSPR recognizes the important role that primary care research plays in strengthening the Canadian health care system and is committed to supporting research in this critical area. IHSPR is planning to launch a suite of targeted primary care initiatives in mid-June 2009. Please see below for **details** about this exiciting primary care initiative and be sure to check the **CIHR Funding Database** in early summer. The Canadian Working Group for Primary Healthcare Improvement, whose purpose is to promote evidence-informed primary healthcare policy and practice for the benefit of Canadians, held its second meeting in January. Made up of thirty leaders in primary healthcare, including researchers, funders, professional association representatives and policy makers from across Canada, the group reviewed three working papers on the benefits of PHC, and committed themselves to carrying the papers forward and developing a business case for sustaining PHC research and improvement. The meeting was sponsored by Health Canada and the Canadian Health Services Research Foundation (CHSRF). In addition to these initiatives, the Canadian Primary Care Sentinel Surveillance Network (CPCSSN), a partnership of CFPC's National Research System (NaRes), the Public Health Agency of Canada, and the Canadian Institute of Health Information (CIHI), has entered Phase two of its groundbreaking work in developing a pan-Canadian sentinel network of networks, collecting electronic information from primary care practices for the study of chronic disease. It is through these and other worthy projects that FM researchers continue to make significant contributions to health care in Canada.

Dedicated Primary Care Funding in CIHR's June Launch

CIHR's Institute for Health Services and Policy Research will be launching a series of funding opportunities in the upcoming June 2009 launch.

We are offering a number of capacity building and short-term research funding opportunities in **primary healthcare**. These include 1) **Masters, PhD and Fellowship** capacity building grants and 2) national and international **Catalyst Research Grants**.

The CIHR **Catalyst Grant** program provides seed money to support health research activities which represent a first step towards the pursuit of more comprehensive funding opportunities (e.g. operating grants, team grants) in areas such as:

- the planning and execution of pilot projects or feasibility studies aiming to generate preliminary data, observations, or knowledge
- the planning and execution of novel projects which clearly demonstrate the potential for significant impact, but which are considered a higher risk in that they may be unsupported by proof of concept / preliminary data
- development and / or validation of new inventions, tools, methodologies, protocols, theoretical models or frameworks
- planning and / or development activities of expert teams (multi-disciplinary, trans-disciplinary, etc.) coming together

to address health research priorities

In addition, we are launching a general call to health services and policy research community for submissions for **Methods and Tools** grants to support research that enables the development and refinement of research methods and tools applicable. The objectives are to support research likely to lead to new breakthroughs in advancing theory, conceptual frameworks, research methods or measurement approaches (qualitative or quantitative) that have broad application to health services and systems in support of the strengthening of the Canadian health care system and improved health for Canadians.

We encourage you to consider applying for these grants and to share this information with your peers and professional networks.

recently completed a study, *Testing the effectiveness of health lines in chronic disease management of congestive heart failure*, funded by the Canadian Institutes of Health Research (CIHR). The study demonstrated that support via regular follow-up telephone calls to heart failure patients can help them feel better, increase compliance with the medications, and help with weight loss, as well as decrease the number of visits to family doctors and hospital emergency departments.
