# **Dedicated Primary Care Funding in CIHR's June Launch**

*CIHR's Institute for Health Services and Policy Research will be launching a series of funding opportunities in the upcoming June 2009 launch.* 

We are offering a number of capacity building and short-term research funding opportunities in **primary healthcare**. These include 1) **Masters, PhD and Fellowship** capacity building grants and 2) national and international **Catalyst Research Grants**.

The CIHR **Catalyst Grant** program provides seed money to support health research activities which represent a first step towards the pursuit of more comprehensive funding opportunities (e.g. operating grants, team grants) in areas such as:

- the planning and execution of pilot projects or feasibility studies aiming to generate preliminary data, observations, or knowledge
- the planning and execution of novel projects which clearly demonstrate the potential for significant impact, but which are considered a higher risk in that they may be unsupported by proof of concept / preliminary data
- development and / or validation of new inventions, tools, methodologies, protocols, theoretical models or frameworks
- planning and / or development activities of expert teams (multi-disciplinary, trans-disciplinary, etc.) coming together to address health research priorities

In addition, we are launching a general call to health services and policy research community for submissions for **Methods and Tools** grants to support research that enables the development and refinement of research methods and tools applicable. The objectives are to support research likely to lead to new breakthroughs in advancing theory, conceptual frameworks, research methods or measurement approaches (qualitative or quantitative) that have broad application to health services and systems in support of the strengthening of the Canadian health care system and improved health for Canadians.

We encourage you to consider applying for these grants and to share this information with your peers and professional networks.

\* National Physician Survey (NPS) 2007 - Fast Facts: The 2007 NPS results are being highlighted in Canadian Family Physician with monthly Fast Facts.

The April issue of *Canadian Family Physician* focuses on **collaboration between family physicians and other health care providers**. Results from the 2007 National Physician Survey (NPS) indicated with whom family physicians regularly collaborated in providing patient care, and whether or not that collaboration was part of a formal arrangement.

The May issue of Canadian Family Physician focuses on **family physicians who provide care for recent immigrants**. Canada has a rich history of immigration, with more than 250,000 new immigrants arriving each year. According to the 2007 National Physician Survey (NPS), 69% of family physicians provide care for recent immigrants to Canada; of those, 6.5% report that recent immigrants make up greater than 10% of their practices.

# **Canadian Cancer Trials: A new national web resource**

The Canadian Cancer Trials website will be the country's first national, bilingual resource for finding cancer-related clinical trials. **CanadianCancerTrials.ca** takes existing cancer trial information and brings it together to help patients and their caregivers find trials. As well, the website will offer better, more accessible information to researchers, policy-makers, funders and administrators.

Canadian Clinical Trials partners include: The Ontario Institute for Cancer Research (OICR), The Canadian Association of Provincial Cancer Agencies and its members and The Canadian Cancer Society.

Set to launch in the spring of 2009, the Canadian Cancer Trials website will allow people to receive email alerts about new trials that may be appropriate for them - or their family member or a patient. This will enable better decision-making for patients who want to take part in trials - and for those caring for them.
