The Canadian Institutes of Health Research (CIHR) have recently proposed a Strategy on Patient-Oriented Research, with the goals of improving health outcomes for Canadians.

While the overall goals of the strategy are laudable, the Section of Researchers, along with the Canadian Working Group for Primary Healthcare Improvement (CWGPHI), which is supported by the Canadian Health Services Research Foundation (CHSRF), are concerned that primary healthcare research needs may not be adequately served by the proposed strategy.

The Section Executive and the CWGPHI have noted that the strategy's proposed units and networks are mainly based upon the premise of a tertiary model of hospital-based healthcare, and that is does not adequately consider primary care researchers who are based in community settings.

Mounting evidence shows that countries with healthcare systems that are oriented to primary healthcare outperform those that are oriented to medical specialization and hospital-based medical care. In the past, primary healthcare research has been seen as a crosscutting theme across all of the CIHR institutes, however, and funding dedicated to primary care research has rarely been provided for any of the Institutes. Funding that has been made available for such research in recent years has been insufficient to allow primary care researchers to continue to produce internationally recognized work, or to allow for and build capacity for research in the community that will support a strong Canadian primary healthcare system.

Both the Section of Researchers and the CWGPHI believe that an emphasis on primary healthcare research is warranted for the CIHR's proposed Strategy on Patient-Oriented Research, and have voiced their concerns in a letter to Dr. Paul Hébert, Strategic Lead and Special Advisor to the President, CIHR. <u>Click here</u> to read it.

\* Call for papers: Intersectoral action to address the social

#### determinants of health Closing date for submission: 30 September 2010.

The International Journal of Public Health is interested in publishing original research on intersectoral action to address the social determinants of health. Because population health is mainly shaped by factors that lie outside of the health sectors, the Ottawa Charter for health promotion identifies intersectoral collaboration for the planning and implementation of interventions as a strategy to address the social determinants of health. Broadly defined as the coordination of efforts stemming from a variety of actors in the public space (various sectors from the government, associations, and private sector), intersectoral action can take many forms. The apparent success of this strategy that is often called upon to support public health planning efforts does not correspond to an equally supportive empirical literature. There exists very little empirical evidence on the efficacy and the conditions of success of this strategy. We are interested in receiving original empirical studies (quantitative, qualitative or methodological) that report on: the quality of measurement instruments to appraise the functioning of intersectoral coalitions; the conditions of success of intersectoral actions; the efficacy of intersectoral actions to address the social determinants of health; methodological issues and practical solutions for the evaluation of intersectoral action.

Manuscripts can be submitted online through the <u>Journal's</u> <u>website</u>. Authors should mention in their comments for the Editor that the submission refers to this call.
